



Marketing Consent Promotion

Terms & Conditions

The Hometree Marketing Consent Promotion (the "**Promotion**") is provided by Hometree Services Limited trading as 'Hometree' ("**Hometree**", "**we**", "**us**" and "**our**") a limited company, registered in England, registered company 12535561 and our registered office is at Hamilton House, 4 Mabledon Place, London, England, WC1H 9BB. Our website is at hometree.co.uk (the "**Hometree site**") use of which is also subject to our Terms of Use.

What is the Promotion?

If you:

1. Provide Hometree with your consent to be included in our marketing "opt in" database between 1st May - 31st May 2024 (inclusive) (the "**Promotion Period**")
2. Opt in via the prescribed opt in method in the Hometree Checkout

Then, subject to these terms and conditions, you will be automatically entered into a prize draw for the chance to win a £500 gift card.

By opting into marketing consent, you are accepting to be bound by these terms and conditions. The winner will be selected at random from all valid entries received during the promotional period. The draw will take place on the last working day of each calendar month.

The winner will be notified via the email address provided during opt-in within 14 days of the draw date. If the winner cannot be contacted or does not claim the prize within 14 days of notification, the Promoter reserves the right to withdraw the prize from the winner and select a replacement winner at random.

Eligibility:

Subject to this, in no event shall we be liable to you for any personal or business losses, and any liability we do have for losses you suffer arising out of or in relation to these terms is strictly limited to losses that were reasonably foreseeable and shall not exceed £150.

We will not be liable or responsible for any failure to perform, or delay in performance of, any of our obligations under these terms that are caused by events outside our reasonable control.

Other important terms:

We reserve the right to amend or withdraw the Promotion at any time on reasonable notice provided that no such amendment or withdrawal will affect your rights. You may not transfer or assign any or all of your rights or obligations under these terms. If we fail to enforce any of our rights, that does not result in a waiver of that right. If any provision of these terms is found to be unenforceable, all other provisions shall remain unaffected. These terms and any document expressly referred to in them represent the entire agreement between you and us in relation to the subject matter of the hometree Promotion. These terms may not be varied except with our express written consent. These terms shall be governed by English law. You agree that any dispute between you and us regarding these terms will only be dealt with by the English courts.
